I (We) hereby assume the sole responsibility for and agree to indemnify and save the aforementioned parties harmless from any loss and expense (including legal fees) by reason of the liability imposed by law upon any of the aforementioned parties for damage because of bodily injuries, including death at any time resulting there from, sustained by any person or persons, including myself (ourselves), or on account of damage to property, arising out of or in consequence of my (our) participation in any Club activity, howsoever such injuries, death or damage to property may be caused, whether or not the same may have been caused or may be alleged to have been caused by negligence of the aforementioned parties or any of their employees or agents, or any other persons.

Greater St. Louis Agility Club

The Greater St. Louis Agility Club is a not-for-profit club. The club's activities include holding sanctioned agility trials under AKC, NADAC, CPE, USDAA, TDAA rules, sponsoring training events to promote dog agility and conducting agility demonstrations for the public to help promote responsible dog ownership and dog agility as a family sport. As a member, I understand that I will be expected to help support these activities.

Club Objectives

1. To promote the sport of dog agility in conformity with the official rules and regulations and policies set forth by any such agility-related organization in which the club membership elects to participate.
2. To protect and advance the interests of the sport by:
 - a) Conducting at least two sanctioned agility tests or events per year under the rules of any agility-related organization approved by the club membership;
 - b) Encouraging sportsmanlike competition at events; and
 - c) Engaging in public education and information efforts.
3. To allow all dogs, regardless of pedigree, including mixed breeds, to participate in club agility activities. Participation in club events shall be governed by the rules of the organization under which the event is held.
4. To foster and promote responsible dog ownership.
5. To have fun.

Membership Voting Rights

Each member in good standing whose dues are paid for the current year shall be entitled to one vote per individual membership or two votes per family membership (one vote per member at least 18 years of age). Junior members (under 18 years) and Associate members are not entitled to vote.

Membership Requirements

Following submission of the application form and payment of dues, a prospective member must attend two (2) membership meetings (held Dog Sport's at Kim in Caseyville, IL on Thursday night at 7:30 p.m. or the weekend at 9:30 during a joint meeting and practice) and work 4-6 hours at a club activity(s) over a period of 2-6 months. A waiver of the meeting requirements can be submitted in writing to the membership chair for club board approval. The written request must give a valid reason (*e.g.*, evening work schedule). If the club board approves the waiver, the applicant must work at three activities (4-6 hrs. each club activity), including but not limited to sanctioned trials, practices, public training days and agility demonstrations.

The Membership Chairperson receives the application and appropriate dues. The Chairperson is responsible for the verification of the required meeting and work activity(s). If an applicant cannot fulfill the requirements within the six (6) month period but has shown an active interest in becoming a member of the club, the board may extend the time by an additional six (6) months. Upon completion of the requirements (2 meetings and 1 activity, or 3 activities) the Membership Chairperson will inform the Club President of the need to vote on the candidate.

Each applicant for a family membership must submit an application and complete the membership requirement for the family application to be considered complete.

At the next scheduled meeting the club board will review and make a recommendation to the general membership. Club voting on acceptance of the applicant takes place by secret ballot. All applicants and guests are asked to leave the room for voting. Applicants will be notified by e-mail or letter of the ballot results.

An applicant is entitled to participate in the member-only practices generally held Thursday evenings and a few Saturday / Sunday mornings at Dog Sports at Kim's. The practice monitor will be published on the yahoo-group page (webpage), along with any deviations to the schedule.

A GSLAC Member is entitled to participate in the member-only practices held at Dog Sports at Kim's. Practice dates are published on the website.

GSLAC Members are encouraged to attend meetings and help at Trials & Club sponsored activities. Members are to be good representatives of the Club and its objectives (exhibiting good behavior, attitude and sportsmanship). A member can be removed from the Club, by the Board, for not following these guidelines.

The sport of agility is very labor intensive, *e.g.*, equipment to be set up and taken down for practices, positions to be filled for trials and training days (gate stewards, ring stewards, timers, scribes, *etc*). However, when all members participate, all members can enjoy the sport. It is imperative that prospective members fully understand the expectations associated with membership. During any typical club activity, everyone is expected to help do something. Our requirements are structured so that both the club members and applicants may have the opportunity to evaluate each other's commitment and interest level.
