NOTICE TO EXHIBITORS

- * The safety of the dogs is the primary concern. By entering this trial, exhibitors acknowledge that they are familiar with the rules and regulations of this sport, and that their dogs are familiar with and able to perform all obstacles safely.
- * Unsportsmanlike conduct: including but not limited to, rough handling, mistreatment, or misconduct of any kind may result in being excused from the ring or trial. All decisions made by the judge(s) are final.
- * Entry fees will not be refunded in the event that a dog is absent, disqualified, excused, or barred from competition by action of the Trial Committee. In the unfortunate death of an entered dog, entry fees will be refunded in full. In season or seriously ill dogs may obtain a partial refund of entry fees, less \$7.00 per run. The trial secretary must receive written notification of the claim prior to the trial.
- * It is expressly understood that exhibitors alone are responsible for the behavior of their dog(s) and/or children. Any exhibitor whose dog(s) and/or children create unnecessary disturbances or repeatedly engage in unsafe or disruptive behavior, may at the discretion of the Trial Committee, be asked to leave the trial site. If an exhibitor is asked to leave the trial site, then the exhibitor will not be refunded any fees that have been paid.
- * Entry fees will not be refunded if the trial cannot open or be completed by reason of riots, civil disturbances, fire, an act of God, public emergency, act of a public enemy, or any other cause beyond the control of the organizing committee/club.
- * Exhibitors are responsible for complete, accurate, and legible information on the entry forms. Any missing funds, illegible or incomplete entries will not be entered into the trial.
- * No electronic training collars will be allowed at this trial site.
- * If a wait list is necessary, it will be maintained until the final move-up date.
